#### **PROPOSAL DESCRIPTION**


- The proposal is to develop a community facility (Phase I) and childcare center (Phase II) at the vacant property adjacent to the Heart of the Rockies Church.
- The proposed community center includes a 3,958 sf building and patio space. The proposed childcare center includes a 8,266 sf building and 6,958 sf play yard.
- The proposal will utilize existing parking and access that serves the church property and the approved parking for the Heartside Hill Residential Development.

- Property is located in the Low Density Mixed-Use Neighborhood (L-M-N) Zone District.
- The proposal is a permitted use in this district and is subject to an Administrative Hearing.
