## PUBLIC NOTICE — TWO-WEEK OPEN COMMENT PERIOD

March 1, 2024

Dear Property Owner or Resident:

The City of Fort Collins has received a Basic Development Review request referred to as **Fossil Creek Subdivision Filing No.2**, #**BDR240002**.

This is a subdivision plat map to define new lot lines and easements following the recent Crestridge Street Right of Way Vacation. Associated with Fort Collins Nissan plan #FDP220011, and ROW Vacation #220006. This location is within the General Commercial (CG) zoning district.

The Land Use Code Section 2.18 allows the Planning Manager to consider this request administratively vs. a public hearing. Prior to a decision by the Planning Manager, there will be a 2-week open comment period during which you can provide comments to the Planning Services Department. It will be:



At the close of the public comment period, the Planning Manager will review the comments, and after consideration shall issue a written decision to approve, approve with conditions or deny the development application based on compliance with the applicable standards. The written decision shall be mailed to the applicant and to any person who provided comments during the comment period and shall also be posted on the City's website at <a href="fcgov.com/developmentreview/proposals">fcgov.com/developmentreview/proposals</a>.
