### PROPOSAL DESCRIPTION

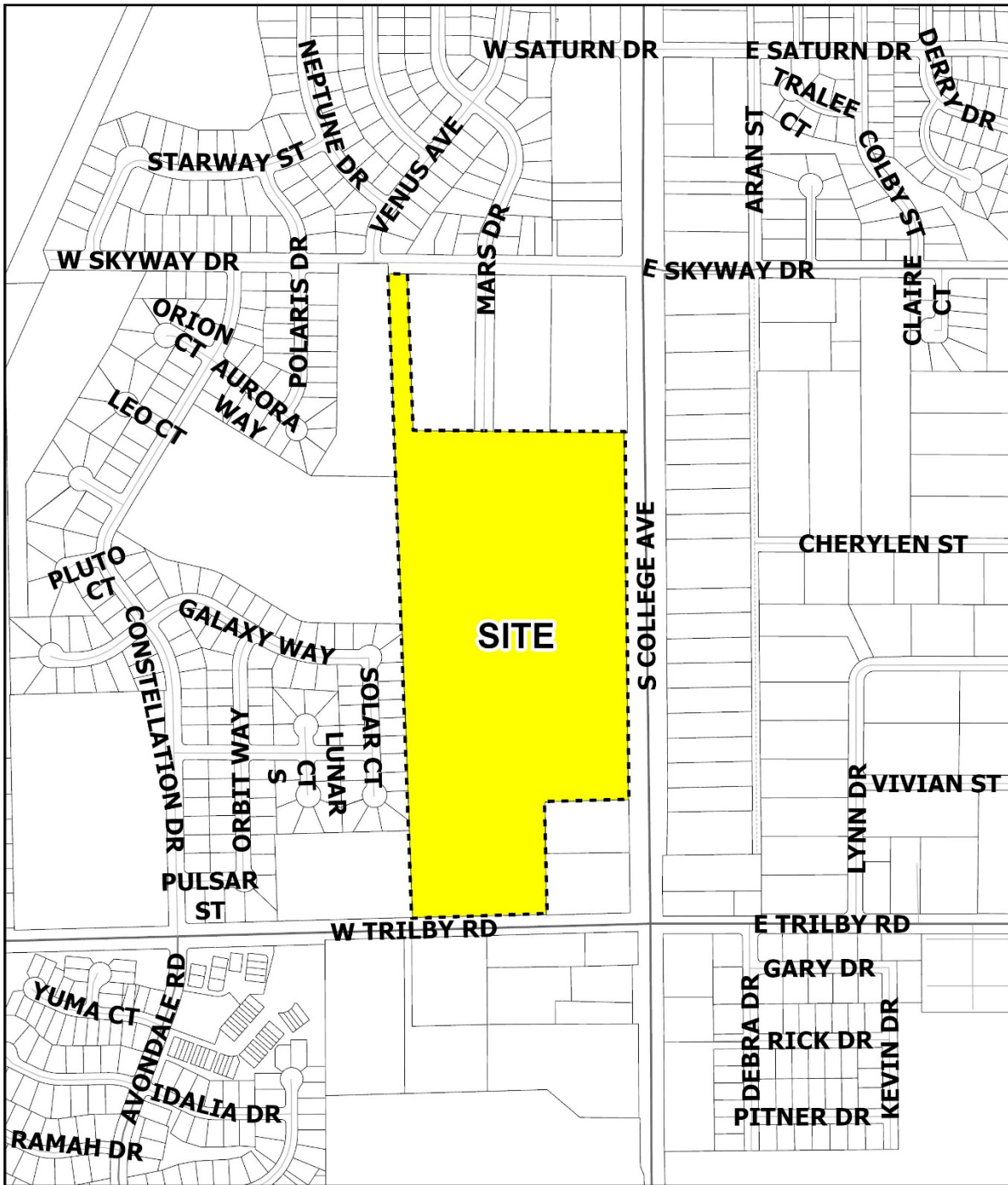
- Develop a neighborhood of 265 townhomes in 2, 3, and 4-plex buildings.
