## PUBLIC NOTICE — TWO-WEEK OPEN COMMENT PERIOD

Dear Property Owner or Resident:

The City of Fort Collins has received a request for a Basic Development Review to establish a duplex at 618 E Myrtle St referred to as **Duplex at 618 E Myrtle Street**, **BDR240004**.

This Basic Development Review proposal is to make the existing duplex (parcel #9713232017) into a legal and approved use. Access taken is to remain from the alleyway off E Myrtle St. The property is in the Neighborhood Conservation, Medium Density (N-C-M) Zone District.

The Land Use Code Section 6.4.1 allows the Planning Manager to consider this request administratively vs. a public hearing. Prior to consideration by the Planning Manager, there will be a 2-week open comment period during which you can provide comments to the Planning Services Department. It will be:


