## PROPOSAL INFORMATION

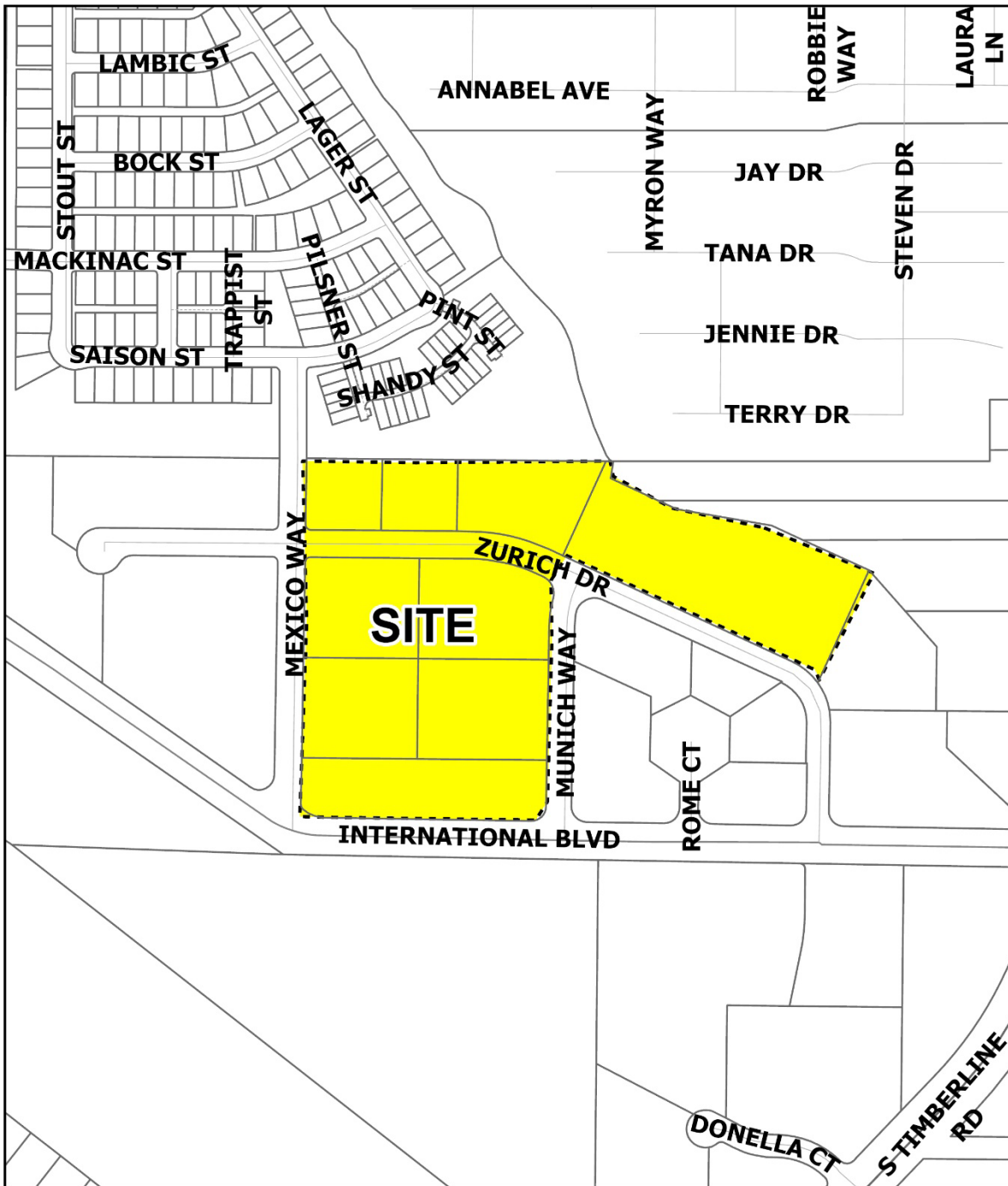
- This is a request for an Overall Development Plan (ODP) for phased development of a private school campus.
