

#### PROPOSAL DESCRIPTION

- A request to demolish the existing homes at 306 Impala Circle and to construct 62 affordable dwelling units in a mixture of single-family attached and multi-family housing types.
- The proposal also includes renovations for the 24 existing duplexes at 400 Impala Circle and a new 8-unit, two-story multifamily building along Mulberry to replace one existing duplex building.
- The site is in the Low Density Mixed-Use Neighborhood (LMN) Zone District.
- This proposal will require a review and public hearing by the Planning & Zoning Commission (P&Z).
- Residents who receive this letter will also receive a letter for the P&Z hearing.
