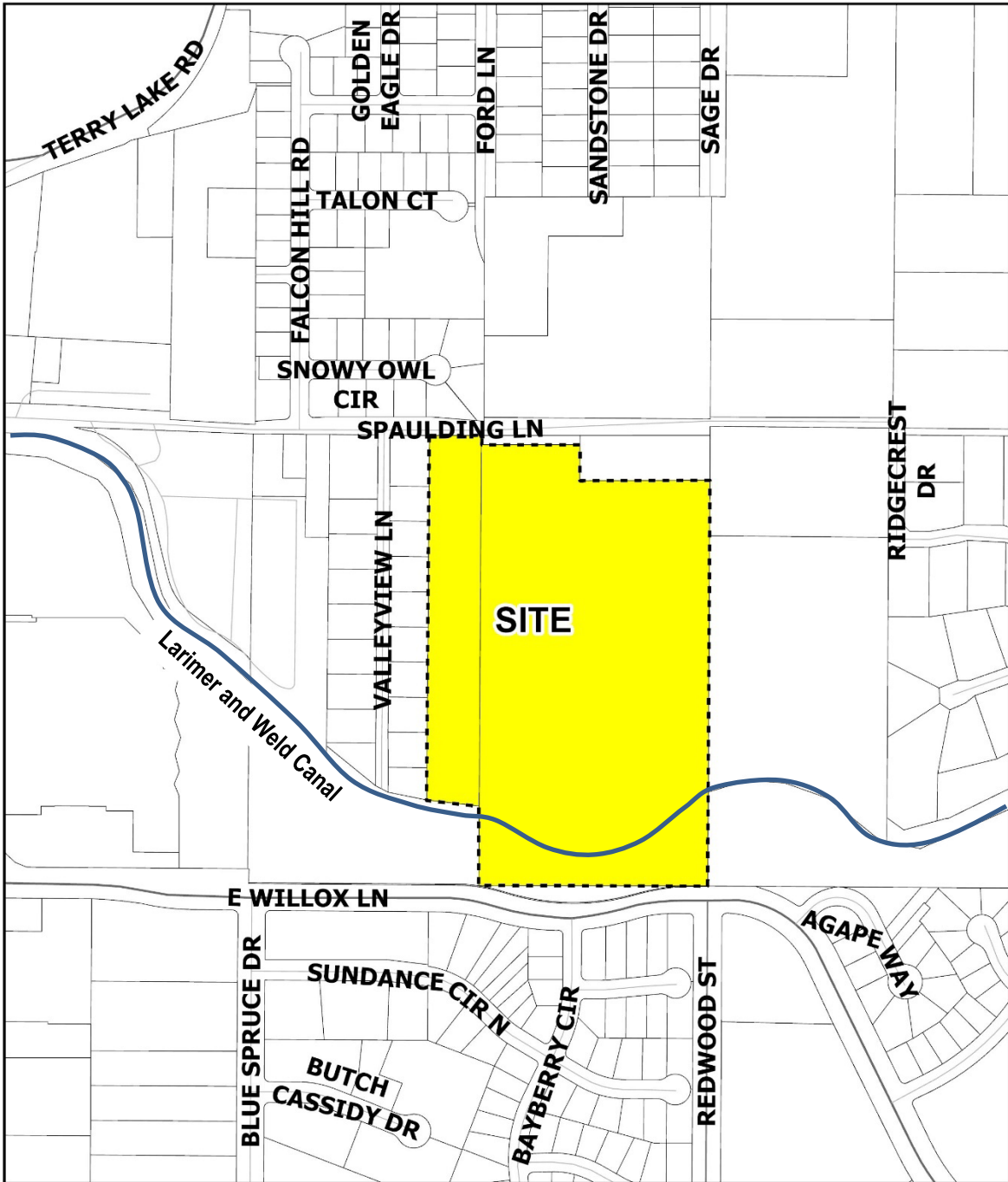

- 21.5 acres spanning two neighborhood zone districts which permit the uses subject to review and public hearing by the Planning & Zoning Commission (P&Z).
