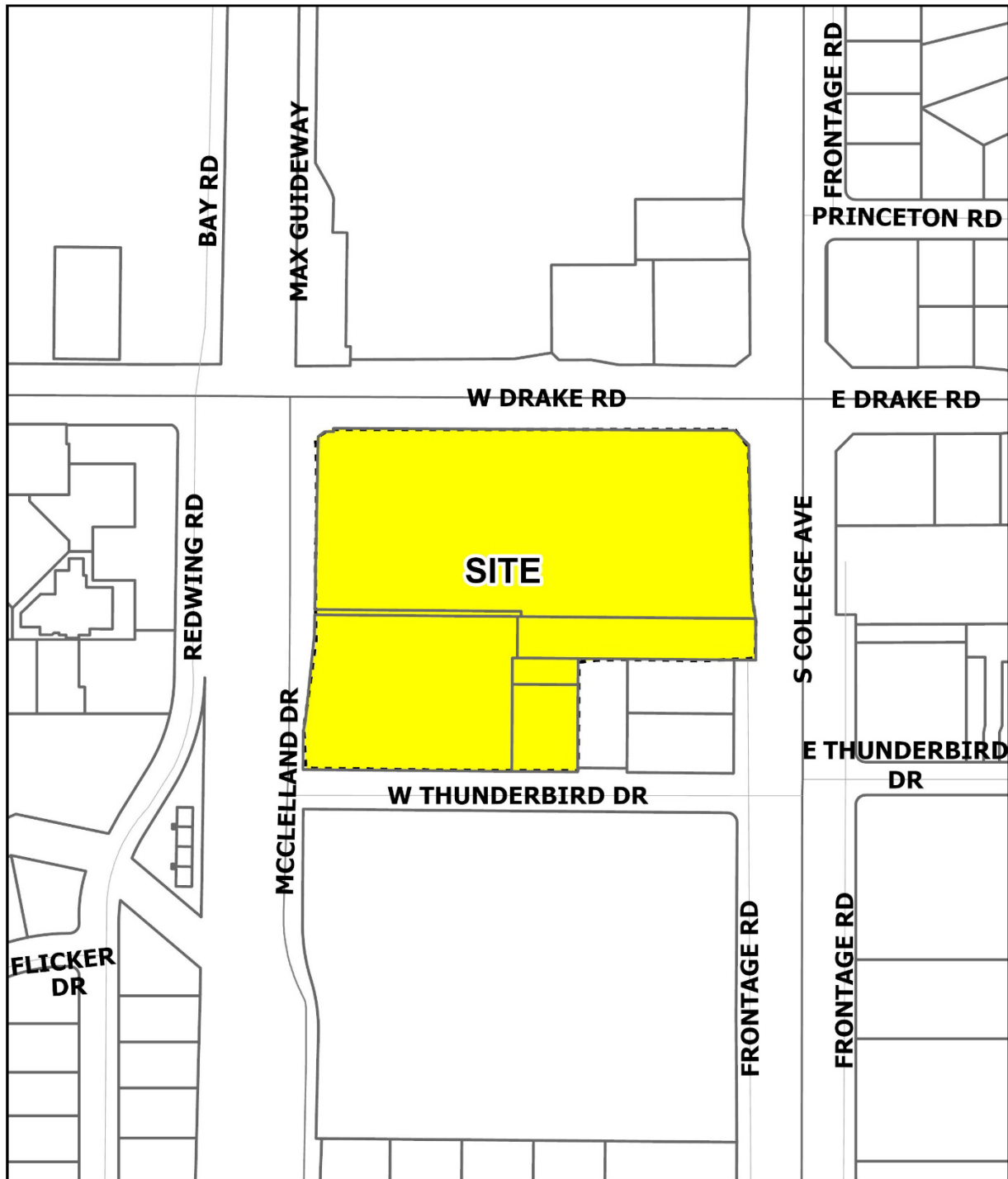

## PROPOSAL DESCRIPTION

- The site is in the General Commercial (C-G) Zone District and is located in the Transit Oriented Development Overlay Zone.
- This proposal will require a review and public hearing by the Planning & Zoning Commission (P&Z).
