

**RULES AND REGULATIONS**

REGARDING THE CITY'S RESIDENTIAL WASTE COLLECTION

PROGRAM FORT COLLINS, COLORADO

ADOPTED MAY 8, 2025

PREVIOUSLY ADOPTED OCTOBER 9, 2023

## **1.0 INTRODUCTION**

1.1 These rules and regulations are adopted pursuant to two Sections of the Fort Collins Municipal Code (the FCMC). Section 12-26 of the FCMC, allows the City Manager to adopt “...rules and regulations concerning the collection, removal and hauling of refuse and rubbish as may be necessary to implement the provisions of this Article [II of Chapter 12] not in conflict with such provisions.” Section 12-29 of the FCMC allows the City Manager by rule to exclude residences from the City’s Residential Waste Collection Program for safety reasons.

1.2 Any term used in these rules and regulations that is defined in Article II of Chapter 12 of the Fort Collins Municipal Code shall have the meaning provided for in that definition.

## **2.0 GROUP ACCOUNTS AND THE CITY’S RESIDENTIAL WASTE COLLECTION PROGRAM**

2.1 A group account that qualifies for the exclusion from the City’s Residential Waste Collection Program (Program) under Section 12-29(d) of the City Code shall provide the City sufficient information on City-provided forms for the City to verify that the group account qualifies for the exclusion. The exclusion requires a group account to have been formed prior to April 28, 2023 and for the group account’s agreement with a solid waste collector to meet all applicable requirements of Chapter 12, Article II and Chapter 15, Article XV of the City Code.

2.2 The group account shall provide the information required by paragraph 2.1 of these rules and regulations to the City not later than December 31, 2023 or during the dates of May 19, 2025 to May 28, 2025.

2.3 Not less than 30 calendar days prior to expiration, termination, or amendment of an existing approved contract, a group account shall provide the City sufficient information on City-provided forms for the City to verify that the group account continues to qualify for the exclusion based on the new or amended contract.

2.4 A group account that meets the requirements of Section 12-29(d) shall be excluded from the Program for the duration of its agreement with the solid waste collector provided the agreement conforms with all applicable requirements of Chapter 12, Article II and Chapter 15, Article XV of the City Code.

2.5 If a group account does not provide the City the information required by either paragraph 2.1 of these rules or paragraph 2.3 of these rules, as applicable, to confirm that it qualifies for the exclusion, residences within the group account will be subject to the requirements of the Program, unless otherwise excluded under section 12-29(a), (b) or (c) of the City Code or subject to a variance issued under section 12-30 of the City Code.

### 3.0 EXCLUSIONS FOR SUBSTANTIAL LIKELIHOOD OF HARM TO PERSONS OR PROPERTY

3.1 The following residential units are excluded from the Program because the provision of residential waste collection services to these residential units would create a substantial likelihood of harm to persons or property:
