Final Paving to Begin in Foothills Park Area

The Foothills Park area has been selected for repair as part of the City of Fort Collins 2013 Street Maintenance Program. The final efforts to pave the road are scheduled to begin August 5. The overlay will last approximately two days. Closures will be required to complete the work. **Resident access will remain throughout the project, however a wait up to 30 minutes may occur- please plan ahead. Residents are strongly encouraged to park in areas which are not affected by construction.** Please note the following construction schedule below (see map on back):

- **August 5-6:** Asphalt paving operations
 - Tradition Dr. CLOSED, from Horsetooth Rd. to Colony Dr.
 - Colony Dr. CLOSED, from Horsetooth Rd. to Blue Mesa Ave.

Project dates are estimates based on favorable conditions; variances may occur due to weather or other unforeseen circumstances.

Parking

Residents who live in the impacted area will need to move all vehicles to an available parking area by 7:00 a.m. the day that your street will be affected. The towing procedure will begin at 7:00 a.m. for all cars that remain parked on the street. Please read the "No Parking" signs carefully to identify the exact date and times when your street/block will be affected by the operation. The placement of these signs shall take place at least 24 hours prior to the commencement of work.

Work Zone Information

Typical working hours are weekdays from 7:00 a.m. to 6:00 p.m., however work may occur outside these times or on the weekends to expedite the work. Road closures will be utilized. Please plan ahead and use alternate routes to avoid the construction zones.

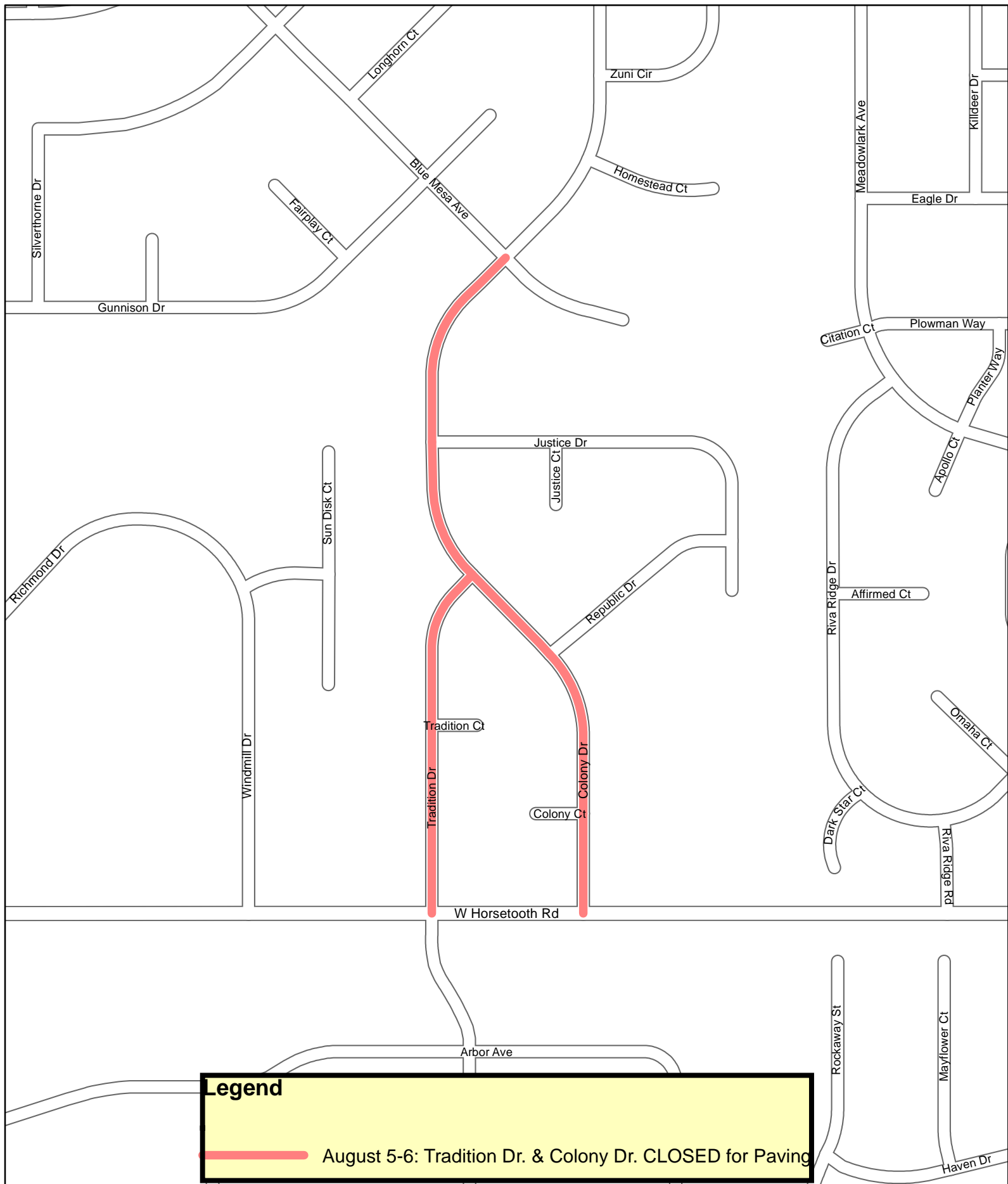


