An application for an off-site construction staging license shall be accompanied by a <u>site and grading plan</u> that shows the following for the site on which the off-site construction staging is to occur:

- Existing grade contours of the site and of adjoining properties;
- Locations of different activities to be located on the site;
- List of materials and equipment to be stored on the site, including the means and methods to safely store any hazardous material or dangerous equipment;
- Any proposed grading necessary to stabilize the site;
- Proposed erosion control measures and storm drainage control measures to prevent wind and water erosion, drainage impacts and tracking mud onto streets;
- Flood ways and flood plains;
- Natural habitat and features;

- Fences;
- Restrooms:
- Existing trees;
- Existing easements and right-of-way;
- Existing underground utilities;
- Other information necessary to describe the site;
- Traffic control plan reflecting means of ingress and egress to be used;
- Mitigation plan to address any adverse impacts to the site, or adjacent parcel, caused by off-site construction staging during and after the staging; and
- Restoration and final site condition plan.

An off-site construction staging site is required to be located within a <u>quarter (.25) of a mile</u> of the construction or development site to be served by the off-site construction staging.

An off-site construction staging license issued shall expire eighteen (18) months after the date of issuance unless an extension is granted. After expiration of an off-site construction staging license, at least four (4) consecutive months shall lapse before a new license is issued for the same parcel.
